HSSA Announces \$235,000 "Access to Health Care" Annual Grant Competition

SPOKANE, WA – The **Health Sciences & Services Authority (HSSA)** of Spokane County announced that it has opened a new grant competition to increase access to health care. The **HSSA RFP #9-2013** – **Access to Health Care** grant will award \$235,000 for grants that increase health care access for the under- and uninsured in Spokane County.

"HSSA's mission includes increasing access to health care delivery services, as well as to improve the capacity of the Spokane region to contribute to advances in health sciences research," said Nancy L. Isserlis, HSSA Board Chair and Spokane City Attorney.

Applicants should have a letter of intent (LOI) in to the HSSA electronically by12 noon on August 31st at grantadmin@hssaspokane.org. HSSA will acknowledge receipt and will coordinate directly with the applicants. A full proposal would be due to the HSSA by 4 pm on September 30, 2013.

HSSA's ninth grant competition helps to meet one of its strategic goals to increase access to health services in Spokane County, and represents a fund of about 15 percent of annual revenues designated for this purpose.

"To date we have awarded \$916,277 in this category and increased access to health care for over 17,000 patients in Spokane County who otherwise would not have been treated," Isserlis

said. In addition, she said, over \$14 million in donated medical services and nearly \$4 million in free pharmaceuticals had been contributed and delivered to people.

HSSA's other strategic initiative is to increase local **health sciences research** and the infrastructure that supports it, and designates 75 percent of its revenues for that purpose. In the latter case, HSSA announced earlier this year that its research grants in all three categories were **open year-round** for proposals at any time. The three research-related categories funded by HSSA are:

HSSA RFP #5 – Investments in human capital to accelerate health sciences research growth in Spokane County. Researchers are required to transfer up to \$1.5 million in current research funding and spend 75% of their time devoted to research, the balance of time to academic teaching and administrative duties.

HSSA RFP #6 – Investments in innovative research to expedite commercialization and spur job growth. HSSA will match up to \$500,000 for research with SBIR/STTR or other organizations "proof of concept" grants when the research and/or commercialization is conducted in Spokane County.

HSSA RFP #7 – Investments in innovative research that advances Spokane as a national leader in health delivery research. HSSA will match up to \$100,000 annually for up to three years for individual research initiatives.

HSSA has invested \$3.1 million to date in health science research and infrastructure that supports approximately \$10.6 million in extramural grant funding to Spokane, an additional \$4 million annual payroll, and 16 direct jobs and 235 WSU-forecasted research-related jobs by 2017.
