  - Address gaps in life sciences area
  - o Initially agency matching grants
  - Within last 2 years added investor-based companies & angel funded companies with very specific criteria
  - Next 15 years
    - Expecting growth and diversification

  - RCW listed above
  - County Resolutions
    - Extends HSSA through 2038
    - Establishes goals and priorities of HSSA
      - Enhance efforts to create a nationally competitive healthcare cluster
      - Catalyze connections with higher education and healthcare that will lead to high wage job creation, economic diversification and long-term sustainability
    - Establishes 3 goals
      - Provide better health and healthcare
      - Create hundreds of well-paying jobs
      - Develop economic engine to power future growth within Spokane County

### HSSA Bylaws and Governance: Dr. Darryl Potyk

  - Original board composed of 9 members 3 each approved by county, city, governor
    - Founding documents allow for 5 more board members WELCOME
    - Terms staggered alphabetically no term limits
