WSU Health Sciences Vice Provost and Pharmacy Dean Appointed to HSSA Board

SPOKANE, Wash. – The **Health Sciences & Services Authority** (HSSA) of Spokane County has announced that Washington Governor Christine Gregoire has appointed **Gary Pollack, Ph.D.** to the Health Sciences and Services Authority (HSSA) Board of Directors.

“We are extremely pleased to have Dr. Pollack join the HSSA Board given his extensive research and administrative experience,” said Nancy L. Isserlis, HSSA Board Chair.

Gary Pollack is the Vice Provost of Health Sciences and Dean of Pharmacy at Washington State University, which he joined in August 2010. He spent several years in ascending positions at the University of North Carolina at Chapel Hill where he most recently served as the Executive Associate Dean, School of Pharmacy. He held a dual appointment in both the School of Medicine and School of Pharmacy.

As Vice Provost of WSU Health Sciences, Dr. Pollack will lead the expanding health sciences mission at the Spokane campus and will facilitate efforts to take an increasingly interdisciplinary approach to teaching and research in the field.

Dr. Pollack has a bachelor’s degree in chemistry and psychology from Knox College in Galesburg, IL, and a Ph.D. in pharmaceuticals, with a concentration on pharmacokinetics and pharmacodynamics from SUNY, Buffalo, NY. The majority of Dr. Pollack’s career has been focused as an independent scientist on issues related to the central nervous systems pharmacokinetics and pharmacodynamics. He is widely published on his laboratory work in blood-brain barrier, substrate distributions with the brain, and drug action on CNS targets. He also has extensive experience as a principal investigator, co-investigator, and consultant on numerous research projects.

Dr. Pollack will serve a four-year term on the HSSA Board that concludes in 2015.
